

2025 F1 Golf Cart Policy For RV Guests

All golf carts, scooters, mopeds and/or ATVs must be registered and assigned a cart number upon entering COTA property.

Registration stickers are \$200 per cart. This fee is only to permit carts to enter COTA property and does not permit carts to be driven outside of the guest's registered space (either in Lot N or Premium RV Lot, as applicable).

For golf carts only, guests may purchase a credential to access the outer loop of the track from 8:00 a.m. to 8:00 p.m. only for \$700. No scooters or mopeds are permitted outside of the RV Lots at any time.

Designated Parking areas will be located at Turn 1, Turn 3 and Grand Plaza. Parking outside of these designated areas is strictly prohibited.

Only guests with outer loop registration will be allowed to park in these designated areas. Any carts with no registration sticker, found outside of its permitted area or parked anywhere other than the RV lots will be fined \$1,500 for each occurrence.

If found in restricted areas, including but not limited to, the paddock, service roads, support paddock, main grandstand or grand plaza will incur additional fines.

All guests with carts will be required to sign a waiver upon entering the COTA facility and shall adhere to all COTA Rules and Regulations including the COTA Golf Cart Policy. Guests will also be required to sign a Credit Card Authorization form authorizing the charge of any fine assessed with respect to any violation of these rules.

Circuit of the Americas Golf Cart Policy

- 1. Pedestrians have the right of way; be courteous at all times.
- Safe Speeds Go SLOW and be cautious as many other vehicles and pedestrian traffic with be occurring on the property.
- The minimum age requirement to operate golf carts, all-terrain vehicles, and utility carts is 18 years old.
- 4. Third parties must provide a certificate of insurance, sign a release form, and assume responsibility before they will be permitted to use a cart.
- 5. Utilize approved seats only.
- 6. Operating these vehicles at night requires proper illumination.
- 7. Seatbelts must be worn if present.
- 8. Must abide by the 15 mph speed limit.
- 9. Use extreme caution when using reverse; avoid doing so if possible.
- Never operate the vehicle while impaired by alcohol, drugs, medication, or injury; or transport passengers whose judgment may be impaired for any reason but not limited to the consumption of alcohol.
- Apply the parking brake and remove the key when not in use. Cable lock recommended when the cart is unattended.
- Obey traffic and golf cart specific signage, directions, signals, and instructions by COTA staff and/or law enforcement.
- Stay on the correct and designated paths or routes COTA has provided for cart traffic.
- 14. RV space holders are permitted to use a golf cart within the RV lot upon signing a release form and assume responsibility before they will be permitted to use a cart.

- 15. COTA is not responsible for lost or stolen carts.
 - 16.Carry and transport cargo only in approved areas of the cart.
 - Refueling carts is not the responsibility of COTA.
 - 18. Permitted cart areas:
 - Service Roads
 - Parking Lots
 - Outer loop road
 - Turn 1Parking area
 - Turn 3 Parking area
 - Grand Plaza Parking area
 - 19. Prohibited cart areas:
 - Main Grandstand
 - Grand Plaza
 - Pit Lane
 - Paddock areas
 - COTA Boulevard
 - During major events, permitted cart areas may be subject to restrictions or credentialing requirements.
 - 21. Go slow and take wide turns, be cautious when going over uneven/unlevel surfaces. Keep both hands on the wheel, do not use your phone while driving, and be attentive to all surrounding traffic both vehicle and pedestrian.
 - 22. Park in only designated cart parking areas, always take your cart key with you when you leave your cart, and please be sure to leave nothing of value in your cart.
 - 23. One person per seat, do not overload the cart with passengers, allow passengers to stand while moving, and please keep all arms and legs inside of the cart.



24. If applicable, please report any issues with your cart to your supervisor immediately and stop picking up passengers until the problem is resolved.

Return your cart every night to the designated stop and return your key.
