

## **RV and Camping Rules & Regulations**

Circuit of The Americas (COTA") welcomes camping and RV guests to the COTA RV Parks, subject to the following rules and regulations. Violations of these policies may result in fines, access restrictions, or the revocation of the privilege to camp at or visit COTA.

1. Purchase of a COTA RV Park space entitles the purchaser to access a space in the designated COTA Camping area only. Other than the COTA Camping area with the purchased space, Guests may not access other parts of the COTA Property unless and to the extent that: (a) the area is open to the public (e.g. COTA Karting during operating hours); (b) there is a free or non-ticketed event (e.g. Cars and Coffee for spectators); (c) there is a ticketed event, and the guest is in possession of a valid and unexpired ticket (e.g. Formula 1 United States Grand Prix); or (d) there is a private event to which the guest has been invited. Guest must only access the areas available to them through access routes designated for the particular event. Wandering around the COTA Property at night, in forbidden areas, in construction zones, or as otherwise prohibited shall be deemed trespassing and may result in eviction from the COTA Property without refund or other legal recourse.

COTA Camping is adjacent to an **active Formula 1 Racetrack**. Climbing over fences or otherwise attempting to enter restricted areas is forbidden and poses significant safety risks. **DO NOT ENTER THE RACETRACK AT ANY TIME UNLESS UNDER COTA'S SUPERVISION FOR DESIGNATED EVENTS.** Even when the racetrack appears unoccupied, it remains hazardous. All individuals must adhere to this rule to ensure their safety and avoid any potential accidents.

- 2. Guests must comply with all security and safety procedures as designated by COTA. These procedures are subject to change at any time.
- 3. Each Lot N RV Site is permitted to have up to six (6) overnight visitors. The site holder is responsible for the conduct of their visitors while on COTA property. All visitors must comply with all RV and Camping Rules and Regulations. Any violations by the site holder's visitors will be the responsibility of the site holder.
- 4. Quiet Hours are enforced from 11:00 PM to 7:00 AM. Please respect your neighbors. External generators are not permitted during Quiet Hours.
- 5. RVs operating on the COTA Property must have liability insurance coverage. Proof of insurance must be made available when requested by COTA or its authorized agents.
- 6. COTA is not responsible for lost, damaged, or stolen property. Guests are responsible for making sure their property is safe and not left unattended.
- 7. Guests will be responsible for any damage done by them to the COTA Property. **DO NOT** park RVs on the pavers.
- No glass of any kind is allowed in the pool area for safety reasons. Guests must adhere to posted pool rules
  and shower house rules. Please be aware that there is no lifeguard on duty, and guests swim at their own
  risk.
- 9. All RV and tow vehicle parking passes must be displayed in plain view upon entering the RV Park and throughout the duration of your stay.
- 10. RV and tow vehicle passes are non-transferable and may not be duplicated. Non-permitted vehicles are subject to be towed away at the owner's expense.
- 11. Copying or counterfeiting passes is forbidden and will result in immediate ejection from COTA property without refund. Violators are subject to prosecution.
- 12. Speed limits in the COTA RV Parks is 7 miles per hour, strictly enforced.



- 13. Only one (1) tow vehicle is permitted per space. Tow vehicles must have a pass displayed at all times. Parking in drive lane or fire lane is strictly prohibited and could result in tow, fines, or future restrictions to camping.
- 14. Any tow/support vehicle must be parked within your designated RV space.
- 15. Fully enclosed parking patterns are not permitted. COTA reserves all rights to change any parking pattern deemed unsafe.
- 16. Box trucks, cargo trucks, rental trucks, and enclosed hauling trucks are not allowed.
- 17. RVs may not be washed within the COTA RV Parks.
- 18. Maintenance and vehicle tuning is not permitted within the COTA RV Parks.
- 19. Tractor-trailer rigs are not permitted in the COTA RV Parks.
- 20. All RVs must be self-contained. External stereo or television speakers are permitted provided noise does not disturb other patrons. No bullhorns, stage lights, DJs or live bands are allowed.
- 21. Nothing within the assigned space can block the sight lines of other spaces.
- 22. EZ-Up tents under 400 square feet that are securely attached to the ground in your assigned space are permitted. COTA reserves the right to have tents taken down if wind exceeds 15 MPH.
- 23. Scaffolding of any kind is not permitted. Ladders and platforms must be permanently attached to vehicles. No platforms more than 12 inches above the roofline are allowed.
- 24. Awnings that are attached to your RV are permitted, provided it fits inside your assigned space.
- 25. No reserving unoccupied spaces.
- 26. Solicitation of any type is not permitted on COTA property. Sale of food, beverages, souvenirs or merchandise of any type is not permitted.
- 27. Trash, recycling, and wastewater must be deposited in appropriate receptacles. Litter or wastewater disposed of in unauthorized areas will be subject to fines.
- 28. Fire lanes and drive lanes must remain unobstructed at all times. Any vehicle blocking a fire lane or drive lane will be towed at the owner's expense.
- 29. Carbon monoxide can be dangerous to you and other guests. Vehicle and generator exhaust must be expelled away from other campsites.
- 30. All pets on the COTA Property must be kept on a leash while outside your personal vehicle. For the comfort of others visiting our property, please clean up after your pet.
- 31. No flashing lights on vehicles or flagpoles. Flagpoles must be securely attached to your vehicle.
- 32. Public intoxication, indecency, or any disorderly conduct will result in the expulsion from the property and possible arrest.
- 33. All patrons are responsible for their own safety and the safety of others. COTA is not liable for actions that endanger your safety or the safety of others.



## 2025 MotoGP Golf Cart Registration Policy – RV Guests

All golf carts, scooters, mopeds and/or ATVs must be registered and assigned a cart number upon entering COTA property.

Registration stickers are \$150 per cart. This fee is only to permit carts to enter COTA property and does not permit carts to be driven outside of the guest's registered space (either in Lot N or Premium RV Lot, as applicable).

For golf carts only, guests may purchase a credential to access the outer loop of the track for \$350, allowing access from 8:00 a.m. to 8:00 p.m. No scooters or mopeds are permitted outside of the RV Lots at any time. Parking outside of the RV lots is strictly prohibited.

Any carts with no registration sticker, found outside of its permitted area or parked anywhere other than designated golf cart parking areas provided will be fined \$1,500 for each occurrence. If found in restricted areas, including but not limited to, the paddock, service roads, support paddock, main grandstand or grand plaza will incur additional fines.

All guests with carts will be required to sign a waiver upon entering the COTA facility and shall adhere to all COTA Rules and Regulations including the COTA Golf Cart Policy. Guests will also be required to sign a Credit Card Authorization form authorizing the charge of any fine assessed with respect to any violation of these rules.

## **Prohibited Items**

All types of open fires, including wood, charcoal, or propane fires are not permitted within RV spaces. Covered propane grills ONLY are permitted but must comply with any city, county or state bans that may be in effect. All guests are required to stay informed of local burn bans and adhere to fire safety regulations.

The use of any off-roading vehicles, dirt bikes and other similar vehicles are not permitted.

Tents larger than 700 square feet are not allowed.

The possession or use of illegal substances of any kind is strictly prohibited.

Firearms, fireworks, smoke bombs, and any type of weapon or explosive devices are strictly permitted. Violators are subject to legal penalties, including possible arrest.

Personal swimming pools, hot tubs and other similar equipment are not allowed.

The use of kites, sky lanterns, candle balloons, drones and other aerial objects is not permitted.

Storing gasoline or other flammable liquids is not allowed.

Non-COTA advertising or signage of any kind is not permitted.
